

Wacom Giveaway Promotion Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR ODDS OF WINNING. ALL FEDERAL, STATE AND LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED BY LAW.

The Wacom Giveaway Promotion ("Promotion") may only be entered in or from the 50 states within the United States or the District of Columbia (excluding all other territories and possessions). Void where prohibited by law. Entries originating from any other jurisdiction are not eligible for entry. You are not authorized to participate in the Promotion if you are not a legal resident of the 50 United States or the District of Columbia.

The following rules (the "Rules") apply to your participation in the Promotion. By entering the Promotion, you acknowledge that you have reviewed and accept and agree to these Rules.

1. **Eligibility.** Participation is open only to legal residents of one of the 50 states of the United States or the District of Columbia (excluding all other territories and possessions) who are thirteen (13) years of age or older as of the date of entry. The Promotion is: (i) subject to all applicable federal, state and local laws; and (ii) void outside of the 50 United States and the District of Columbia and where prohibited, taxed or restricted by applicable law. Employees, officers and directors of Wacom Co., Ltd., doing business as "Wacom" ("Wacom"), and its parent company, subsidiaries, affiliates, partners, dealers, advertising and promotion agencies, manufacturers or distributors of Promotion materials and their immediate families (i.e., parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees, officers and directors are not eligible to enter.

2. **Who We Are.** We are Wacom Co., Ltd., having an address at 12121 NE 99th Street, Suite 2170 Vancouver, WA 98682. Unless otherwise expressly stated, the Promotion is in no way sponsored, endorsed or administered by, or associated with any third party.

3. **How to Enter.** The Promotion will begin on October 5th, 2026 at 6:00 a.m. Eastern Standard Time and will end November 29th, 2026 at 9:00 p.m. Pacific Standard Time ("Promotion Period").

You may enter the Promotion by, no later than the end of the Promotion Period, "opting in" to receive marketing emails from Wacom using the "opt-in" procedures specified in the initial introductory email you receive from Wacom. Once you complete the "opt-in" process using the information provided in the initial introductory email, you will automatically be entered in the Promotion. You may also enter the Promotion by hand printing your name, address, email address, age on a 3" x 5" index card and mailing it in an envelope with proper postage to Wacom Giveaway Promotion, 12121 NE 99th Street, Suite 2170 Vancouver, WA 98682. For each mail-in request, you will be entered into the Promotion. All entries become Wacom's exclusive property, and none will be acknowledged or returned. All mail-in entries must be received by Wacom prior to the end of the Promotion Period. Any other attempted form of entry is prohibited; no automatic, programmed, robotic or similar means of entry are permitted.

Only one entry per person is permitted. If multiple entries are received from the same entrant, only the first entry submitted by that entrant will qualify for entry into the Promotion; subsequent entries submitted by that entrant will be disqualified. No automated entry devices and/or programs are permitted. Wacom is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Wacom.

4. Prizes.

Promotion winners will receive the following prizes ("Prize(s)"):

One (1) prize winner will receive a set of 25 Wacom Intuos drawing tablets.

If a winner is under the age of majority in their jurisdiction of residence as of the end of the promotion as identified above, then such individual's parent or legal guardian must provide written permission allowing said individual to accept a Prize. Prizes are non-transferrable. No substitutions or cash redemptions will be provided; however, Wacom reserves the right to substitute a Prize in whole or in part for a prize of equal or greater value in the event that any component of a Prize is unavailable for any reason. Prizes may not be sold, bartered or transferred. Prizes do not include any additional expenses, including, but not limited to, federal, state and local sales or other taxes and surcharges, which are solely the responsibility of the Prize winner.

The approximate retail value of 25 Wacom Intuos drawing tablets is nine hundred ninety eight dollars and seventy five cents (\$998.75). The approximate retail value of the Prize represents Wacom's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the Prize turns out to be less than the stated approximate retail value, the difference will not be awarded in cash.

The Promotion winners will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release within five (5) calendar days of Prize notification.

If a Prize is returned as undeliverable, or if a potential winner rejects his/her Prize or fails to comply with these Rules, the Prize will be forfeited and an alternate winner may be selected from among all remaining eligible entries. If the winner is under the age of majority, the Affidavit of Eligibility and Liability/Publicity Release must be signed and submitted by the winner's parent or legal guardian. Prizes not claimed by eligible winners in accordance with these Rules within two (2) months of Wacom's receipt of the Affidavit of Eligibility and Liability/Publicity Release will not be awarded and will remain Wacom's property. Prizes will be fulfilled approximately within one (1) week after the conclusion of the Promotion.

5. Random Drawing/Odds. The winner will be selected in a random drawing from all eligible entries on or about 11/30/2026. The odds of winning depend on the number of eligible entries received. Prize winners will be announced on or about 12/2/2026 and will be notified using the email address provided to Wacom as part of the "opt in" process.

6. Conditions. All federal, state and local taxes are the sole responsibility of the winners. Participation in the Promotion and acceptance of a Prize constitutes the winner's permission for Wacom to use their name, address (city and state), likeness, photograph, picture, portrait, voice, biographical information and/or any statements made by the winner regarding the Promotion or Wacom for advertising and promotional purposes in perpetuity and without notice to or approval of the winner and without additional compensation to the winner, except where otherwise prohibited by law. By participating in the Promotion, entrants and each winner agree to release and hold harmless Wacom, and its respective advertising and promotion agencies and their respective parent companies, subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers and directors, from any and all liability, for loss, harm, damage, injury, cost or expense whatsoever including without limitation, property damage, personal injury and/or death which may occur in connection with, preparation for, travel to, or participation in the Promotion, or possession, acceptance and/or use or misuse of a Prize or participation in any Promotion-related activity and for any claims based on publicity rights, defamation or invasion of privacy and merchandise delivery. Wacom is not responsible if the Promotion cannot take place or if any Prize cannot be awarded. Entrants who do not comply with these Rules, or attempt to interfere with the Promotion in any way will be disqualified. As noted above, there is no purchase or sales presentation required to participate in the Promotion and a purchase does not increase odds of winning.

7. Additional Terms. In the case of dispute as to the identity of any entrant submitted via the "opt-in" process, entry will be declared made by the authorized account holder of the email address submitted at the time of entry. The "authorized account holder" is the natural person who is assigned an email address by an Internet access provider, online service provider, or other organization (e.g. business, educational, institution, etc.) responsible for assigning email addresses or the domain associated with the submitted email address. Any potential winner may be requested to provide Wacom with proof that such winner is the authorized account holder of the email address associated with the winning entry. Wacom, its affiliates, partners and promotion and advertising agencies are not responsible for technical, hardware, software, telephone or other communications malfunctions, errors or

failures of any kind, lost or unavailable network connections, website, Internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of entry information (regardless of cause) or failed, incomplete, garbled, jumbled or delayed computer transmissions which may limit one's ability to participate in the Promotion, including any injury or damage to a participant's or any other person's computer relating to or resulting from participating in the Promotion or downloading any materials in the Promotion.

Wacom reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend the Promotion should (in its sole discretion) virus, bugs, non-authorized human intervention, fraud or other causes beyond its reasonable control corrupt or affect the administration, security, fairness or proper conduct of the Promotion. In such case, Wacom will select the winner(s) from all eligible entries received prior to and/or after (if appropriate) the action taken by Wacom. Wacom reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole discretion, to be tampering with the entry process or the operation of the Promotion or any associated website. Wacom may prohibit an entrant from participating in the Promotion or winning a Prize if, in its sole discretion, Wacom determines that said entrant is attempting to undermine the legitimate operation of the Promotion by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other entrants or Wacom's representatives.

8. Use of Data. Wacom may collect and process personal data about entrants in accordance with its privacy policy. Entrants should review this policy at <https://www.wacom.com/en-us/privacy>. By entering the Promotion each entrant consents to the collection, use and distribution of his/her personal information (i.e., information that identifies an entrant as an individual, such as home telephone number, age and home address) by Wacom in accordance with its privacy notice, and for the purposes of implementing, administering and fulfilling the Promotion.

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, WACOM SHALL NOT BE LIABLE TO YOU OR TO ANYONE ELSE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES, INCLUDING BUT NOT LIMITED TO DAMAGES FOR LOST PROFITS, GOODWILL, USE, DATA OR OTHER INTANGIBLE LOSSES (REGARDLESS OF WHETHER WACOM KNEW OR HAD REASON TO KNOW OF THE POSSIBILITY OF SUCH DAMAGES), HOWEVER CAUSED, WHETHER BASED ON CONTRACT, NEGLIGENCE, STRICT LIABILITY IN TORT, WARRANTY OR ANY OTHER LEGAL THEORY, ARISING OUT OF OR RELATED TO YOUR PARTICIPATION IN THE PROMOTION OR RECEIPT OF A PRIZE. Some states do not permit limitations or exclusions on warranties, so the above limitations may not apply to you.

11. Disputes. All issues and questions concerning the construction, validity, interpretation and enforceability of these Rules shall be governed by, and construed in accordance with, the laws of the State of Washington, without giving effect to any choice of law or conflict of law rules (whether of the State of Washington or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Washington.
